In compliance with the basic objectives of the Cooperation Council for the Arab States of the Gulf, and in conformity with the objectives of the GCC Unified Economic Convention seeking to achieve economic integration among GCC member states, and aware of the crucial role played by GCC industries in the economies of the GCC member states, it becomes vital for the member states to take necessary measures against dumping, subsidy and increase of imports, which cause injury, threat of injury, or retardation to GCC industries.

Amending the names of some Indian and Chinese companies producing/exporting ceramic and porcelain tiles mentioned previously in Official Gazette No.27.

In conformity with the GCC Common Law on Anti-Dumping, Countervailing and Safeguard Measures and its Rules of Implementation (Regulation), and referring to the official gazette No. 27 regarding the imposition of definitive anti-dumping duties against the GCC imports of ceramic and porcelain tiles , under GCC-Unified Tariff Code from item: (6907), other than those of subheading (69073000) originating in or exported from the People's Republic of China and the Republic of India, and in reference to the Ministerial Committee's decision on authorizing the Permanent Committee's to deciding on requests to change or amend the names of companies participating in investigations in the official gazette issued by the TSAIP.

In reference to the Permanent Committee's decision on meeting no.40 dated on 27-28 of Dec. 2021 about the approval of the requests on amending some of Chinese and Indian companies' names.

GCC-TSAIP hereby announces the approval of amending the names of some Indian and Chinese companies , without an amendment to the amount of the imposed duties , and with the continuation of imposing duties on the other companies mentioned in the list of names in the official gazette No. 27 issued on April 30 2020 as the following:
